Laboratory note: The estimated concentration of the unknown peak in the sample is 0.11% | Currently PharmLabs laboratory can not confirm an unidentified peak in your chromatogram due to interference (only with highly concentrated D8 products) from which we believe to be either (+)-delta-THC or delta-THC. At this time there are no reference standards available for (+)-delta-THC. (+)-delta-THC is a different compound from the main (-)-delta-THC cannabinoid and, therefore, these two compounds may have different efficacies. Using the most advanced instruments and techniques available, the separation of (+)-delta-THC and delta-THC is problematic for the scientific community as a whole. PharmLabs believes the unidentified peak to be a combination of (+)-delta-THC and delta-THC with the majority, if not all, of the concentration being (+)-delta-THC. Total (+)-delta-THC concentration is estimated to be: 0.85%
